Toshkent shahrida Webster universitetining ta'lim dasturlarini amalga oshirish Markazi, bundan keyin "Markaz" deb yuritiladi va O'zbekiston Respublikasi Markaziy banki, bundan keyin "Markaziy bank" deb yuritiladi, bundan keyin birgalikda "Tomonlar" deb yuritiladi, ta'lim va ilmiy tadqiqotlar sohasida hamkorlikni rivojlantirishdan o'zaro manfaatdorliklarini inobatga olgan holda, bundan buyon "Memorandum" deb yuritiladigan Anglashuv Memorandumini tuzdilar. Memorandum quyidagi qoidalarni o'z ichiga oladi:

1. Maqsad

Mazkur Memorandumdan maqsad tomonlar o'rtasida ilmiy va ta'lim sohasidagi hamkorlikni teng huquqli va o'zaro manfaatli asosda rivojlantirishdan iborat.

2. Hamkorlikning asosiy yo'nalishlari

Tomonlar o'rtasidagi hamkorlikning asosiy yo'nalishlari quyidagilardan iborat:

2.1. Ilmiy tadqiqotlar sohasida hamkorlik qilish, ilmiy tadqiqot ishlarini birgalikda amalga oshirish;

2.2. Hamkorlikni rivojlantirish va ilmiy tadqiqotlar samaradorligini oshirish maqsadida Markaziy bank xodimlari barcha qo'shma ilmiy loyihalarda faol ishtirok etib, ilmiy maqolalar chop etishda hammuallif sifatida ishtirok etish;

Center for the implementation of educational programs of Webster University in Tashkent hereinafter referred to as CIEP WUT, and The Central Bank the Republic of Uzbekistan hereinafter referred to as CBU, hereinafter collectively referred to as the Parties, taking into account the mutual interest in the development of cooperation in the field of education and scientific research, compiled a Memorandum of Understanding, hereinafter referred to as the "Memorandum". The memorandum contains the following provisions:

1. Purpose

The purpose of this Memorandum is to develop scientific and educational cooperation between the parties on a par and mutually beneficial basis

2. The main areas of cooperation

The main areas of cooperation of the Parties are:

2.1. Collaboration in the field of scientific research and jointly conducting research activities;

2.2. To foster collaboration and enhance research outcomes, CBU staff actively participate in all joint research projects and contribute as co-authors in research article publications;

2.3. Axborot va boshqa resurslardan, ilmiy ma'lumotlar bazalaridan birgalikda foydalanish, o'quv adabiyotlari va o'quv qo'llanmalarini ishlab chiqish va almashish, o'zaro manfaatli hamkorlikdagi nashrlarni tayyorlash;

2.4. Qo'shma ma'ruzalar, seminarlar, treninglar va master-klasslar o'tkazish;

2.5. Qo'shma ilmiy-amaliy va ilmiy-uslubiy konferensiyalar, forumlar, seminarlar va boshqa tadbirlarni tashkil etish va o'tkazish;

2.6. Markazning so'nggi bosqich bakalavriat va magistratura talabalarini Markaziy bankda amaliyot o'tash uchun jalb qilish;

2.7. Tomonlar o'zaro manfaatdorlik ko'rsatadigan ilmiy va ta'lim sohasidagi hamkorlikning boshqa shakllarini rivojlantirish;

2.8. Barcha ma'lumotlar, shu jumladan tadqiqot natijalari asosida tuzilgan xulosalar, tomonlarning o'zaro roziligisiz oshkor etilmaslik, tarqatilishi yoki uchinchi shaxslarga boshqa tarzda berilmaslik.

3. Moliyalashtirish masalalari

3. Ushbu Memorandum Tomonlar zimmasiga moliyaviy majburiyat yuklamaydi.

Har bir Tomon, agar yozma ravishda boshqacha kelishilmagan bo'lsa, ushbu Memorandum doirasidagi faoliyatni amalga oshirish bilan bog'liq xarajatlarni o'zi qoplaydi.

4. Tomonlarning javobgarligi

4.1. Tomonlar qo'shma tadqiqot loyihalarida foydalaniladigan barcha ma'lumotlarning maxfiyligi va himoyasini ta'minlash, ular xavfsiz tarzda qayta ishlanishi, cheklangan kirish imkoniyatiga ega bo'lishi va ma'lumotlarni himoya qilish bo'yicha tegishli qonun va qoidalarga rioya etilishi uchun to'liq javobgardir.

4.2. Qonunchilik talabi va ushbu Memorandum talablarni buzish amaldagi qonun hujjatlariga muvofiq javobgarlikka sabab bo'ladi.

5. Huquqiy maqom

2.3. Joint use of information and other resources, scientific databases, the development and exchange of educational literature and teaching aids, the preparation of joint publications of mutual interest.

2.4. Conducting joint lectures, workshop-training, and master classes.

2.5 Organizing and conducting joint scientific and practical and scientific conferences, forums, seminars, and other events.

2.6. Attracting graduate students of Bachelor's and Master's degrees from CIEP WUT for an internship at the CBU.

2.7. Development of other forms of scientific and educational cooperation, in which the parties show mutual interest.

2.8. All information, including conclusions drawn on the basis of the research results, shall not be disclosed, distributed, or otherwise provided to any third parties without the mutual consent of the parties.

3. Funding issues

3. This Memorandum does not impose any financial obligations on the Parties.

Each Party shall bear its own costs associated with the implementation of activities under this Memorandum, unless otherwise agreed in writing.

4. Responsibility of the Parties

4.1. The Parties must bear full responsibility for maintaining the confidentiality and privacy of all data utilized in joint research projects, ensuring its secure handling, restricted access, and compliance with applicable data protection regulations.

4.2. Violation of the requirements of the legislation and of this Memorandum shall result in liability in accordance with the applicable laws and regulations.

5. Legal status

5.1. Ushbu Memorandum Tomonlarning o'zaro niyatlarini ifodalaydi va huquqiy majburiyatlarni yuzaga keltirmaydi. U Tomonlar o'rtasida hamkorlik va o'zaro tushunish uchun asos bo'lib xizmat qiladi.

6. Yakuniy qoidalar

6.1. Tomonlar o'rtasidagi hamkorlikning o'ziga xos shakllari faoliyatning barcha jihatlarini bo'yicha tomonlarning xohish-istaklarini inobatga olgan holda alohida shartnomalar yoki bitimlar bilan belgilanadi.

6.2. Tomonlar o'rtasidagi kelishmovchiliklar, ushbu Memorandumning shartlari va qoidalarini talqin qilishdagi kelishmovchiliklar maslahatlashuvlar va muzokaralar yo'li bilan hal qilinadi.

6.3. Ushbu Memorandumga o'zgartirishlar faqat Tomonlarning o'zaro yozma roziligi bilan kiritilishi mumkin.

6.4. Ushbu Memorandum Tomonlar imzolagan paytdan boshlab kuchga kiradi va 5 (besh) yil davomida amal qiladi.

6.5. Ushbu Memorandum tomonlardan biri tomonidan kamida olti oy oldin yozma ravishda ogohlantirilgan holda bekor qilinishi mumkin.

6.6. Ushbu Memorandum o'zbek va ingliz tillarida 2 (ikki) nusxada tuzilgan bo'lib, o'zbek tilidagi nusxasi ustuvor ahamiyatga ega.

5.1. This Memorandum reflects the mutual intentions of the Parties and does not create any legally binding obligations. It serves as a basis for cooperation and mutual understanding between the Parties.

6. Final provisions

6.1. Disagreements of the parties, differences in interpretation of the terms and conditions of this Memorandum are resolved through consultations and negotiations

6.2 Any disputes between the Parties, including those arising from the interpretation of the terms and provisions of this Memorandum, shall be resolved through consultations and negotiations.

6.3. Changes to this Memorandum could only be made by mutual written consent of the Parties.

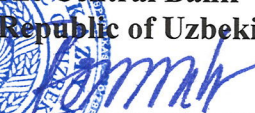
6.4. This Memorandum enters into force from the moment of its signing by the Parties and is valid for 5 (five) years.

6.5 The validity of this Memorandum may be terminated by one of the parties, subject to prior written notice of at least six months

6.6. This Memorandum is executed in 2 (two) counterparts, in Uzbek and in English, with the Uzbek language version prevailing.
